

TEN YEAR LIMITED WARRANTY FOR PLAZIT 2001 POLYCARBONATE SHEET



Subject to the conditions set herein, Plazit 2001 (hereinafter: "Plazit") from Kibbutz Gazit 19340 Israel hereby grant _____ (hereinafter: "the Customer") the following warranty for its Polycarbonate + 2UV protective layer sheets (hereinafter "the Products"):

Warranty

1. We warrant that the Product retains its light transmission. This means that the sheets will have a light transmission after 10 years which is no more than 6% lower than at the time of delivery.
2. The Product retains its rigidity. This means that sheets will have a modulus of elasticity of <2100 MPa after 10 years.
3. The Product retains its strength and does not become brittle. This means that the tensile stress at yield is < 55 MPa after 10 years. Plazit warrants it shall replace faulty Products, as detailed hereinunder, with no additional charge to the Customer, if the following conditions are met:
 - 1) Notification to Plazit as to the faulty Products was made during a period of 10 years from the purchase date of the faulty Products (hereinafter "the Warranty Period") and without delay.
 - 2) The Invoice issued to the faulty Products is presented to Plazit, showing the name and address of the Customer, the purchase date and a detailed description of the Products purchased, including the Plazit pallet number.
 - 3) The fault in the Products had occurred despite full and complete, demonstrable adherence to Plazit's instructions with regard to the Products, by the Customer, including:
 - a) PLAZCARB IUV (one side UV protection layer), MUST be installed with the protection layer in face the sun radiation. No significant sun radiation will be by reflections at the unprotected side.
 - b) The product must be stored, transported fabricated and installed) or used in a manner suited to the material.
 - c) The product must not be adversely affected by connecting, fixing and/or sealing elements.
 - d) The product must be protected against the adverse influences of chemicals.
 - e) The product must not be thermoformed.
 - f) The Product, may only be exposed to the weather the UV side.
 - g) The above conditions being met, drilled or riveted sheets are covered by the 10 year guarantee weather resistance only.

If the claim is justified, we will replace the material free of charge ex works as stipulated below.

If replacement material cannot be supplied, the customer will be refunded with the original purchase price according to the same pattern. Further claims are excluded.

Replacement of faulty material:

Period after purchase date percentage replaced Up to 5 years 100 %

Between 6 - 7 years 60%

Between 8 - 10 years 30%

The warranty detailed in article 1 hereinabove is the full and only warranty given by Plazit to the Customer and Plazit shall not be liable for any damages to the Customer, other than as specifically stated hereinabove.
